A foreign affairs analyst (FAAs/IRAs) or international relation analyst is expert in one or more areas of international relations, such as foreign policy, international trade, international and domestic security, and regional studies. They are capable of understanding and using approaches, methods and tools of different international economic, law, political theories, and regional-civilizational studies, using their professional foreign language skills for understanding the complex globalized international system. They are capable of deep analysis of different macro-regions' or sub-regions' economic, political and social interdependencies. They are capable of Ph.D. level education.

- Foreign affairs analysts perform research on issues related to area of their expertise they may impact policies and positions of governments, humanitarian organizations, and multinational corporations. Their work also includes assisting in the development of plans and policy formations and analyzing the function of agencies and organizations and their impact on international relations.
- Foreign affairs analysts help non-governmental organizations, government agencies and private sector corporations alike formulate or revise their policies based on what is going on in strategically important parts of the world. Foreign affairs analysts also study the influence and effect of an organization or an agency in a specific country or region in the world. This means IRAs must be knowledgeable of the history, culture and political system of the country or region of the world they study and must be up-to-date on current events. A nation's political and business ties are also of key strategic importance when conducting analyses.
- Foreign affairs analysts have a deep understanding of how countries relate to each other politically, economically, in social or cultural terms and diplomatically. As such, they are responsible for managing the political and commercial interests of an organization.

## 8. Final thesis:

**Student is capable of working autonomously on IR** related issues, proving theoretical knowledge and practice skills using relevant analytical and practice methods, reflecting the knowledge area knowledge base and practice standards.

- In case of classical foreign policy areas, the graduate demonstrates knowledge concerning factors and determinants of behavior of states to regional and sub-regional environment, capable of analyzing the nature of regional or sub-regional state-system, the nature of state actors, regional IGOs, INGOs.
- Understanding global governance and public policy issues, understanding public and private goods in global and regional settings in different functional policy areas. The student can explore the nature of global and regional, transnational political regimes, global, regional, transnational policy making processes.
- In case of global and regional policy functional area, analysis of external policy action areas, programs, projects, the graduates demonstrate and reflect the project specific knowledge, planning, implementing, monitoring phase, level of quality, innovation process management and reflections on it. They demonstrate quantitative methodology, basic concepts, new directions, institutions and globalization processes.
- In case of foreign policy management, the graduates are capable for exploring networks, regimes, management culture depending on actors, issue management, exploring multilevel policy involvement, network management, coalition building areas.
- In case of analysis of international private sphere, graduates demonstrate key concepts and knowledge areas of business global policy trend analyses, demonstrate underlying competencies, techniques and perspectives see (like the BABOK Guide Standards)
- In case of analyzing international political impact of issues, graduates demonstrate knowledge, skills and tools and organizations concerning advising, advocacy, activism, lobbying. Capable of analyzing planning cycle,

force field analysis, problem tree, good example, stakeholders; for influence mapping, SWOT and triangle analysis, the policy product life-cycle and role of key people, using marketing approach (influencing mix), and understanding think tank functions, making battle-map, understanding policy-readiness, understanding policy entrepreneurship and papering policy brief, modes of networking, engaging in public participation, campaigning and alliance building, analyzing impact of think tank on foreign policy issues.

- In case of regional and area studies the graduates can analyze the historical legal communities and international legacies of civilizations (religious, state development pathways, regional security, economic, social, political and cultural landscapes, most important challenges of security, regional public good making processes, processes of regional system development, the role of the region in global geopolitical landscapes. The students are capable of analysis of regional political architecture of states, and reflecting liberal, realist, cosmopolitan and evolutionist analyses of regional foreign policy processes. In case of regional and area studies the graduates are able to analyze civilizational, religious, political movements, main trends concerning the individuals: including social issues, mobility, and regional transformational processes.

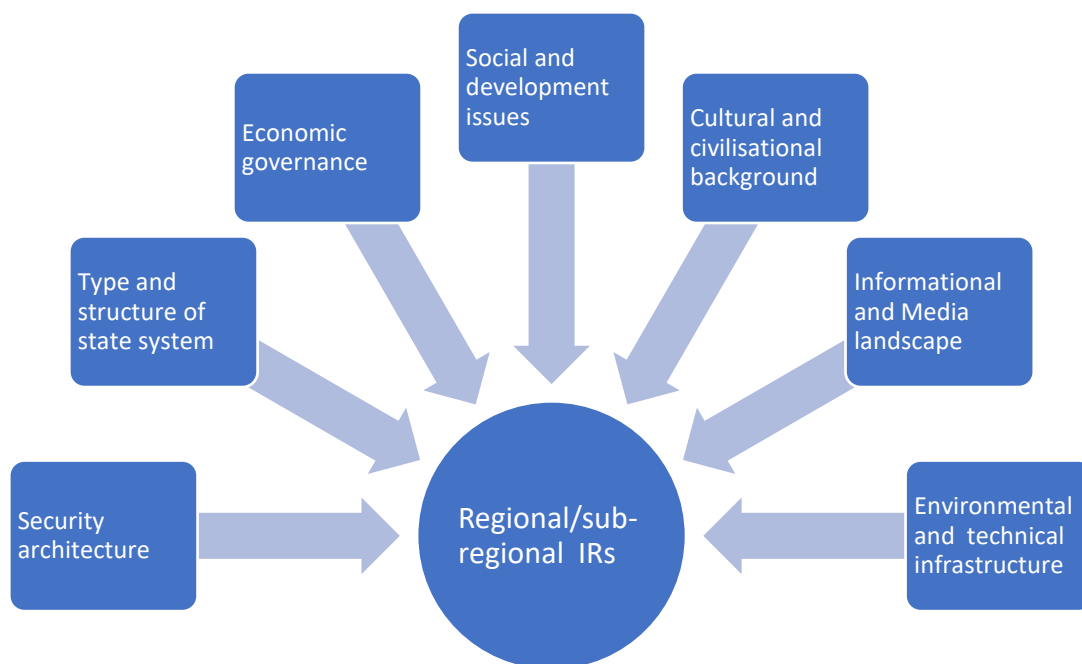

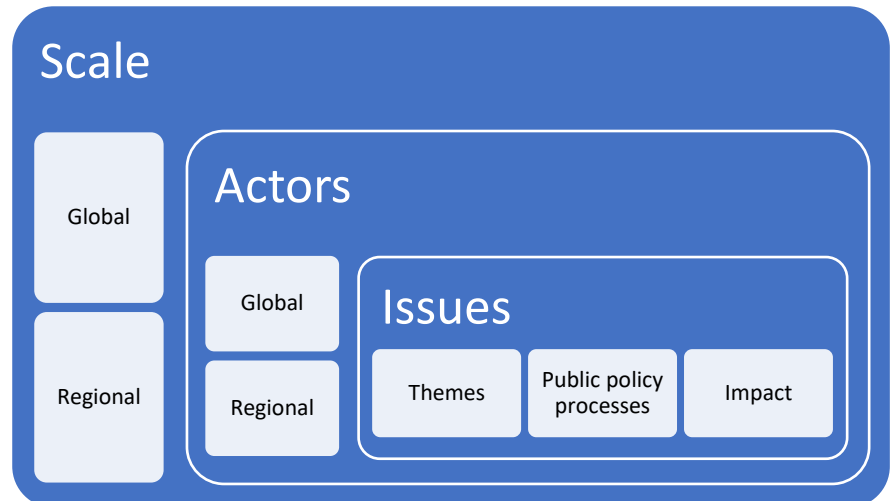
